

RESOLUTION NO. 1988 - 4548A RESOLUTION DECLARING RESULTS OF SPECIAL
MUNICIPAL ELECTION CONSOLIDATED WITH THE
PRESIDENTIAL GENERAL ELECTION,
NOVEMBER 8, 1988

WHEREAS, a Special Municipal Election was held and conducted in the Town of Woodside in consolidation with the Presidential General Election on Tuesday, November 8, 1988, for the purpose of submitting Measure "J" to the vote of the voters;

WHEREAS, it appears that notice of said election was duly and legally given, that voting precincts were properly established, that election officers were appointed and election supplies furnished, that in all respects said election was held and conducted and the votes cast thereat received and canvassed, and the returns thereof made, determined and declared in time, form and manner as required by the General Laws of the State providing for and regulating municipal elections in said Town;

WHEREAS, the Council of said Town met in the Town Hall Conference Room, 3155 Woodside Road, Woodside, California, on Wednesday, November 30, 1988, to canvass the returns of said election; and

WHEREAS, said canvass was duly completed and the results thereof are as hereinafter set forth:

NOW, THEREFORE, IT IS HEREBY RESOLVED, as follows:

1. That said Special Election was held and conducted in the Town of Woodside, County of San Mateo, State of California, on Tuesday, November 8, 1988, in the time and in the form and manner as required by law.
2. That there were twelve voting precincts established in said Town for the purpose of said held election.
3. That a canvass of the votes cast in said Town for or against Measure "J" was duly held on Wednesday, November 30, 1988, in accordance with law.
4. That the total number of votes in said Town of Woodside at said election was 3,207 (including 687 absentee votes).

5. That the number of votes received for and against Measure "J" in said precincts and by absentee ballots, together with the whole number of votes received in the entire Town are as follows:

7. That at said Special Election held in the Town of Woodside on Tuesday, November 8, 1988, Measure "J" was approved by a majority vote of the voters of Woodside as hereinbefore set forth.

8. This Resolution shall be entered in full in the Minutes as a statement of the results of said election.
